- 2. The control system has not been investigated for functional safety evaluation or limiting applications.

- 4. For all AC supplied models of the VS and VR series (except for VS300 Series 300N and VR75 Series 75N models), the duty cycle is 80% at 50°C maximum ambient temperature and it decreased linearly to 50% at 60°C maximum ambient temperature and 20% at 70°C maximum ambient temperature.
- 5. For AC supplied VS300 Series 300N models, the duty cycle is 50% at 45°C maximum ambient temperature and it decreased linearly to 20% at 60°C maximum ambient temperature.
- 6. For AC supplied VR75 Series 75N models, the duty cycle is 80% at 45°C maximum ambient temperature and it decreased linearly to 50% at 60°C maximum ambient temperature and 20% at 70°C maximum ambient temperature.
- 7. For all DC supplied models the duty cycle is 80% at 60°C maximum ambient temperature and it decreased linearly to 50% at 65°C maximum ambient temperature and 20% at 70°C maximum ambient temperature.
- 8. The installation of the actuator in the final application shall prevent excessive heat transfer from the valve to the actuator by additional mounting bracket or similar device. To be evaluated in the end application.
- 9. With the P5 (Drive and Recopy PCB) option the maximum torque is 250N.
- 10. All actuators shall be mounted on the vertical axis (indicator toward the top).
- 11. All actuators shall be protected in the end application by an over current branch circuit protection device (circuit breaker or fuse) rated 3A. Ac, or 5A dc for dc supply version.
- 12. Safety factor 1.5 has to be taken to determine torque. For example, VS300 m.N (max.) to be operated at torque 200m.N.
- 13. All documents including manual shall not contain the words "Failsafe or/and battery backup for failure as an option"
